

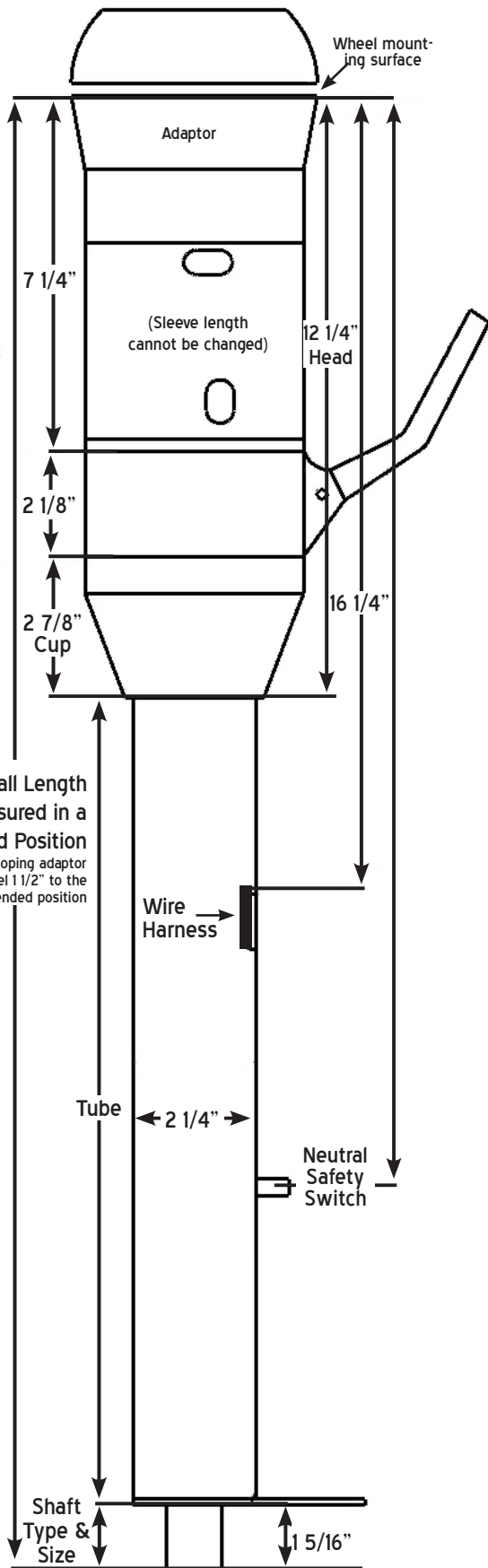

Overall wire harness position is measured from top of adaptor in collapsed position to top of wire harness location. Standard is 16 1/4". Max total is 25". Cruise control max is 20"

Rotation starts at 12 o'clock from seating position
